**1. Sponsor:** Jostens, Inc., 7760 France Avenue, Suite 400, Minneapolis, MN 55435 (“Sponsor”).

**2. Entry Period:** The Black Friday Yearbook Sweepstakes (“Promotion”) begins at 12:00 a.m. Central Time on November 23, 2020 and ends at 11:59 p.m. Central Time on November 29, 2020 (“Entry Period”).

**3. Eligibility:** Entrants must be, as of the date of entry, (a) a legal resident of the fifty (50) United States or the District of Columbia and (b) age 13 or over. Anyone between the ages of 13 and 17 or who is under the age of majority in their state, province or territory of residence (a “Minor”) must obtain the permission of his or her parent or legal guardian (“Guardian”) to enter.
